Program Information

The Bachelor of Applied Technology degree in Healthcare Administration will prepare graduates for entry to mid-level management positions in a healthcare or medical facility. Graduates of this program will provide valuable expertise in the area of healthcare systems management, finance, medical staff roles and responsibilities, reimbursement mechanisms, the electronic medical record, privacy and legal issues related to the healthcare industry. The program model is a skills-based degree, with emphasis placed on instruction, assessment and student demonstration of the required knowledge and skills necessary for workplace success, as defined by local, regional and national healthcare standards. It is delivered in a format to meet the need of the working professional.

Designed for adults who juggle work and family, the TJC School of Professional and Technical programs offers its Healthcare Administration, Bachelor of Applied Technology accelerated degree in flexible, fiveweek sessions. This allows you to complete your upper-division courses in Healthcare Administration in as little as one-and-a-half years while only attending one night a week. Core general education classes required for our accelerated bachelor's degree program are available online, and in the evening or weekends, allowing you to finish on your own schedule.

Accelerated Format

Upper-division Healthcare Administration courses are offered one night a week, from 5:30 p.m. to 9:30 p.m. Coursework is completed both online and in a seminar-style classroom setting. This format allows you to maintain a job and family life, and still successfully pursue your degree.

Classroom Instruction

Interact with tenured faculty and seasoned healthcare professionals in a structured, face-to-face learning environment. The classroom allows for high-level discussions, bringing theory and application together while connecting to your professional experiences.

Healthcare Administration, BAT Program Admission Requirements

Applicants are eligible for admission to the program if they have earned an associate degree in a healthcare or business program.

Applicants with prior college-level coursework or an AAS, AA or AS degree which is non-healthcarerelated or those without the required associate degree should contact the department chair for additional admission information for the degree program.

BAT Program Admission Requirements

- Associate degree in Healthcare Administration (AAS), Medical Office Management (AAS), Health Information Technology (AAS) or Business Management (AAS).
- Please consult with academic advisor or department chair if you have an associate degree in

another field or other related healthcare field.

• Must have earned a cumulative Grade Point Average (GPA) of 2.5 or higher in associate degree.

If you meet the requirements as stated above, the steps to apply are as follows:

- Apply for admission to TJC. You must be accepted as a student at TJC before you can apply to the Healthcare Administration program. Your application for admission to TJC can be completed and submitted online at www.tjc.edu/apply. Admission to TJC does not guarantee admission into the Healthcare Administration program. The number of students admitted into the Healthcare Administration program is limited and you must submit a separate application to be considered.
- You must submit an official transcript from each college you have attended, even if you have courses in progress or the completed coursework is not required for the Healthcare Administration degree plan. All transcripts must be received in the TJC Registrar's Office by the last day of the admission period.
- When you submit a transcript, you must:
 - Submit an official transcript
 - Submit the transcript to the TJC Registrar's Office
 - Submit a transcript with the most recent semester of coursework
 - Complete the online Transcript Evaluation Request form

For more information, go to TJC.edu/transcripts. If a college submits transcripts electronically, contact the TJC Registrar's office at 903-510-2400 to verify that TJC is able to accept the electronic version. It is your responsibility to make sure transcript(s) are received by the deadline.

| HTMS 3300 | 3 | Legal Aspects of Healthcare Management The purpose of this course is to develop and apply aspects of critical thinking skills to everyday situations in healthcare. In this course, the student will be given case studies in ethical principles, legal issues and ethical standards in the health service delivery system. | | | |
| HTMS 3301 | 3 | Introduction to Healthcare Systems This course has been designed to provide the student with a historical perspective of the U.S. healthcare system, its evolution over time and an analysis of the current trends. Students will study the various methods of healthcare delivery and organization seen in this country as well as the current social and economic forces we see today and in the future. | | | |
| HTMS 3302 | 3 | Quality Assurance and Risk Management This course addresses risk management in healthcare. Topics will include ways to identify and evaluate risks as a means to reduce injury to patients, staff members and visitors within an organization. | | | |
| HTMS 3304 | 3 | Strategic Talent Management for Medical Systems To strategically manage the talent and performance of an organization and implement proven strategies, tools and processes to help manage talent and performance. | | | |
| HTMS 3305 | 3 | Employment Law in Healthcare Management This course is an overview of various laws and regulations that determine the rights and obligations of employees and employers. Topics covered include the nature of the employment relationship and common law principles, prohibitions against discrimination on the basis of certain protected characteristics such as race and gender, wage and hour law, the Family Medical Leave Act, the National Labor Relations Act and other similar areas of labor and employment law. | | | |
| HTMS 3410 | 4 | Healthcare Finance & Administrative Management This course is the study of healthcare financial management. Students will be introduced to the theory, concepts and tools necessary to make financial decisions in a healthcare environment. | | | |

| HTMS 4300 | 3 | Global Health Systems This course is an introduction to understanding the current status and challenges of global health. Students will look at some of today's most critical global health concerns and the importance of their impact on the world and their local environment. | | |
| HTMS 4302 | 3 | Healthcare Statistics and Data Analysis This course covers the fundamentals of statistics with a strong emphasis on practical application in health administration using Excel. | | |
| HTMS 4303 | 3 | Healthcare Technology and Medical Systems Residency This class is taken in the final semester of the program. Students will participate in healthcare facility rotations for selected departments, culminating in a major project designed to include the knowledge and competencies they have acquired during the rotation assignments. | | |
| HTMS 4304 | 3 | Seminar in Healthcare Administration The purpose of this course is for students to research, analyze and present on selected areas of current administration and management issues in healthcare. Examples would be organizational/individual time management, total quality management, MACRA/MIPS and other current issues facing healthcare management. | | |
| HTMS 4306 | 3 | Comprehensive Program Review An academic culmination of coursework that draws on all courses and job experience to demonstrate their competency via a comprehensive examination through HTMS courses. The exam will be administered at the conclusion of the course. | | |
| HTMS 4401 | 4 | Introduction to Healthcare Informatics This course covers the resources and methods for the management of health information. Students will be introduced to the electronics and information technology used in patient care and the trends for the future as the demands and use of technology increase. | | |
