# **INSTRUCTIONS - READ CAREFULLY**

Complete the form and go to Remedy Intelligent Staffing located at 909 E. Loop 323, #510 in Tyler. Remedy Intelligent Staffing will process the criminal history and background investigation as well as administer the substance abuse panel 10 drug test. A report will be sent to the student. The report must be turned in to the instructor by the given deadline. **You must have your background investigation form complete upon arrival.**

### AREAS OF ASSESSMENT

## **Social Security Number Authenticity**

Confirms that the social security number reported is a valid number that is not part of the death database. Compares the date and location the social security number was issued against the applicants address history and date of birth.

### **Identity Trail Check**

Compares addresses and names reported by credit and other agencies against the applicant's reported name and address information. This assessment will ensure that no one's identity has been "stolen". Remedy Intelligent Staffing does not perform a credit check and this assessment will not impact your credit history in any way.

## **Driver's License Authenticity Check**

Determines if the reported driver's license exists and is registered in the name, address and date of birth supplied by the applicant.

### **Sex Offender Registry Review**

Reviews the relevant, current databases to determine whether or not the applicant is a registered sex offender.

## **Criminal History**

Searches and reviews <u>at least</u> 7 years of records. Reviews and evaluates any admission related convictions (felony and misdemeanor) including deferred adjudications. Reviews and evaluates the current state of residence and all states (where available) of residence, or counties of residence (if applicable) for at least the past 7 years. All findings, whether positive or negative, are reported to Tyler Junior College Emergency Medical Services Programs.

## **Substance Abuse Panel 10**

The substance abuse panel is a drug test that screens for 10 commonly abused substances. Additionally, the test screens for creatinine, temperature and PH levels as a way of ensuring candidate integrity.
